A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING A \$2,125,000 LOAN REPAYMENT FROM THE SOUTHCREST REDEVELOPMENT PROJECT AREA, AND APPROPRIATING \$2,125,000 TO BE LOANED BACK TO THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO.

WHEREAS, the Council of The City of San Diego (the "City") has previously given general approval of the financing plans for the Central Imperial and Southcrest Redevelopment Areas to the Redevelopment Agency of The City of San Diego (the "Agency"); and

WHEREAS, the Agency has previously borrowed one million six hundred fifty-five thousand dollars (\$1,655,000) in Community Development Block Grant ("CDBG") funds; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That it hereby accepts as a loan repayment from the Southcrest Redevelopment Project two million one hundred twenty-five thousand dollars (\$2,125,000) from CDBG and sales tax funds that had previously been loaned to the Agency.
- 2. That it hereby transfers to the Agency a total of two million one hundred twenty-five thousand dollars (\$2,125,000) as an interest bearing loan, to be used in the Fiscal Year 1995-96 Southeastern Economic Development Corporation ("SEDC") Project Budget for project implementation costs as follows:
