A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE APPLICATION FOR GRANT FUNDS FOR THE STATE OF CALIFORNIA HAZARD MITIGATION GRANT PROGRAM (SECTION 404) FOR THE WINTER/LATE WINTER STORMS OF 1995 (FEMA-DR-1044-CA AND FEMA-DR-1046-CA) FOR THE PURPOSE OF OBTAINING FEDERAL FINANCIAL ASSISTANCE UNDER THE ROBERT T. STAFFORD DISASTER RELIEF AND EMERGENCY ASSISTANCE ACT OF 1988, P.L. 93-288, AS AMENDED FOR THE FOLLOWING PROJECT:

ACQUISITION AND INITIAL RESTORATION OF FLOODPLAIN PROPERTIES LOCATED WITHIN THE FOCUSED PLANNING AREA OF THE PROPOSED OTAY VALLEY REGIONAL PARK

WHEREAS, the Federal Emergency Management Agency (FEMA) allocates funds for disaster relief associated with the winter storms of 1995, including use of the funds to prevent future flood damage by acquiring floodplain lands and insuring that these lands would not be developed; and

WHEREAS, FEMA allocates these funds to the State of California for the purpose of administering grants to local agencies; and

WHEREAS, the Governor's Office of Emergency Services has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing application by local agencies under the program; and

WHEREAS, said procedures established by the State of California Governor's Office of Emergency Services require the applicant to certify by resolution the approval of application(s)

before submission of said application(s) to the State; and

WHEREAS, said application(s) contain assurances with which the applicant must comply; and

WHEREAS, the applicant will enter into an agreement with the State of California for acquisition of the project; NOW, THEREFORE,

BE IT RESOLVED, that the City Council of The City of San Diego hereby:

1. Approves the filing of an application for the State of California Hazard Mitigation Grant Program under the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988 for the above project.


2. Certifies that said applicant understands the assurances and certification in the application form.

3. Certifies that said applicant has or will have available the required match prior to acquisition of, or commencement of any work on, the project included in this application.

4. Appoints the City Manager or his representative(s) as agent of the City of San Diego to conduct all negotiations, execute and submit all documents, including but not limited to applications, amendments and so on, which may be necessary for the application for the aforementioned grant program.
