

RESOLUTION NUMBER R- 287186

ADOPTED ON APR 15 1996

WHEREAS, on December 9, 1991, The City of San Diego (the "City") entered into an agreement with Dudek & Associates, Inc., for as needed environmental consultant services in connection with the Multiple Species Conservation Program, as reflected by the original agreement on file in the office of the City Clerk as Document No. RR-279131; and

WHEREAS, the agreement was amended on September 27, 1993, by Amendment No. 1, on file in the office of the City Clerk as Document No. RR-282687, and on June 26, 1995, by Amendment No. 2, on file in the office of the City Clerk as Document No. RR-286009; and

WHEREAS, the City and Dudek desire to make further amendments for the purpose of adding \$77,523 to the contract value thus increasing the not-to-exceed contract amount to \$577,523, and by extending the agreement duration to five (5) years; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Amendment No. 3 to the Agreement with Dudek & Associates, Inc., for as needed environmental consultant services on the Multiple Species Conservation Program, under the terms and conditions set forth in

Amendment No. 3, on file in the office of the City Clerk as Document No. RR- **287186**.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$77,523 from Sewer Fund #41509, CIP 45-910.2, Predesign and Engineering, to Sewer Fund #41509, CIP 45-910.3, Program Planning and Studies.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$77,523 from Sewer Fund 41509, CIP 45-910.3, is hereby authorized, solely and exclusively, for the purpose of providing funds for the above project.
