


RESOLUTION NUMBER R- 287187

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the Clairemont Friendship Center, Inc., a non-profit California Corporation (Agency") that would provide \$85,500 in CDBG Funds, for the design and construction of the Agency's additional parking lot with connection to the original parking, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 287187.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$95,000 from CDBG Fund 18531, Clairemont Friendship Center, Inc., is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.


CERTIFICATION OF UNENCUMBERED BALANCE
