BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$700,000 from the Public Liability TransNet Fund (Dept./Fund 81144) for the Property Damage Claim of 5680 and 5690 Genoa Drive, 5673 Mill Peak Road and 6082 Adobe Falls Road to CIP 12-097.0, Genoa Drive Slope Repair.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,400,000 from CIP 12-097.0, Genoa Drive Slope Repair, is hereby authorized, solely and exclusively for the purpose of providing funds for the Genoa Drive Slope Repair.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon advice from the administering department, is hereby authorized to transfer excess budgeted funds to CIP 52-432.0, Mission Gorge Road - Old Cliffs Road to Princess View Drive, provided that the City Auditor first furnishes a certificate demonstrating that the funds necessary for such expenditures are, or will be, on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to request advance funding from SANDAG through Debt Financing in an amount not to exceed \$700,000.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to execute any necessary documents relating to the receipt of said funds from SANDAG.

BE IT FURTHER RESOLVED, that the City of San Diego is hereby authorized to be responsible for paying its proportional share of the issuance costs and overall annual debt service requirements of the SANDAG Debt Financing Program and that such costs shall be the first priority use of the City of San Diego Annual Allocation of TransNet Revenue.
