RESOLUTION APPROVING SECOND EXTENSION OF AGREEMENT FOR DATA PROCESSING SERVICES BETWEEN THE COUNTY OF SAN DIEGO, THE CITY OF SAN DIEGO, AND THE SAN DIEGO DATA PROCESSING CORPORATION.

WHEREAS, The City of San Diego ("City"), the County of San Diego ("County") and the San Diego Data Processing Corporation ("Corporation") have previously entered into an agreement which was placed on file May 14, 1984, in the Office of the City Clerk as Document No. RR-260693, to provide for the joint development and operation of an automated system to be known as the Regional Urban Information System ("RUIS"); and

WHEREAS, this original agreement was extended on April 11, 1994, by agreement on file in the Office of the City Clerk as Document No. RR-283679, which extension expires by its own terms on May 14, 1996; and

WHEREAS, the City, County, and the Corporation are continuing to develop the RUIS Strategic Plan to further the goal of creating and implementing a multi-year agreement to manage RUIS operations, which agreement would create a management structure similar to the current RUIS organization and which would control the creation, maintenance and sale of RUIS products and services; and

WHEREAS, in order to complete the RUIS Strategic Plan and specifically to complete the task of evaluating various options and determining which future management structure will best be

able to market RUIS data, the City Manager ("Manager"), the County Chief Administrative Officer ("CAO"), and the Corporation's Chief Executive Officer ("CEO") recommend extending the current agreement through December 31, 1996, and further recommend that the Manager, CAO and CEO be granted the authority to exercise an option to renew the agreement through June 30, 1997, should the parties believe it is in the public's interest to do so; NOW, THEREFORE,

BE IT RESOLVED, by the City Council that, subject to the conditions set forth in paragraphs (1) and (2) below, the Manager is authorized to execute the SECOND EXTENSION OF AGREEMENT FOR DATA PROCESSING SERVICES BETWEEN THE COUNTY OF SAN DIEGO, THE CITY OF SAN DIEGO AND THE SAN DIEGO DATA PROCESSING CORPORATION, which once executed is to be placed on file with the City Clerk as Document No. RR- 287290 .

- (1) The Manager may execute this Second Extension to
  Agreement only if the County Board of Supervisors and
  Corporation's Board of Directors approve this extension; and
- (2) The extension is subject to funding in the City's FY 1997 budget.
