

RESOLUTION NUMBER R- 287388

ADOPTED ON MAY 28 1996

APPROVING PARCEL MAP W.O. 960106

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Timothy J. Graves, Registered Civil Engineer, entitled "Parcel Map W.O. 960106, being a Consolidation and Lot Line Adjustment of Lots 11 to 16, inclusive of Map No. 12844 filed July 23, 1991 and Parcel 2 of Parcel Map No. 16265 filed filed October 18, 1990, in the City of San Diego, County of San Diego, State of California according to maps thereof recorded in the Office of the San Diego County Recorder," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easement for public street ^{Judicial Court, Town Centre Drive,} purposes and dedicates and names the same and Eastgate Mall, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that those previously dedicated portions of Judicial Drive and Judicial Court enumerated on said parcel map as being abandoned and not delineated thereon are vacated and closed to public use pursuant to Section 66499.20-1/2 of the Subdivision Map Act.


BE IT FURTHER RESOLVED, that those easements for sewer and drainage purposes enumerated on said parcel map as being abandoned and not delineated thereon are found to be unnecessary for the public purposes for which they were granted and are hereby abandoned pursuant to Section 66499.20-1/2 of the Subdivision Map Act.

BE IT FURTHER RESOLVED, that said Council certifies that the City of San Diego is owner in fee simple of the area delineated within said map and that said Council approves the preparation and recordation of said map and the Clerk of said City is hereby authorized and directed to endorse a certificate upon said map, as and for this act of the Council.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized to endorse upon said parcel map, as and for the act of the Council, that said Council has approved said parcel map; that the easement abandonments, street vacations and street dedication, as shown on this parcel map, are accepted or approved on behalf of The City of San Diego, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said parcel map to the County Recorder of the County of San Diego, California.
