WHEREAS, each year the San Diego Police Department sponsors the School Safety Patrol Summer Camp; and,

WHEREAS, this camp is held at the Palomar County School Camp; and

WHEREAS, the School Safety Patrol Summer Camp affords fifth and sixth grade students an educational growth and recreational experience; and,

WHEREAS, the San Diego Unified School District has agreed to provide transportation for students to and from the camp; and,

WHEREAS, the transportation to be provided will consist of four (4) seventy (70) passenger buses to depart from San Diego Jack Murphy Stadium at 8:30 a.m. on July 9, July 15, July 22 and July 29, 1996, departing from Camp Palomar at 12:30 p.m. on July 12, July 18, July 25 and August 1, 1996; and

WHEREAS, the Agreement by the San Diego Unified School District to provide transportation is conditional on the specified terms; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the City of San Diego will assume total responsibility for the conduct of students while riding the bus, including, but not limited to, vandalism to school equipment, liability for damages resulting from objects thrown from the bus and medical expenses for injury while entering, leaving or moving

about the bus; and,


- 2. That the City of San Diego will bear an equal share of the liability over and above insurance limitations if the School District meets the following performance standards: (a) all drivers are licensed in accordance with the California Vehicle Code for transporting school students; (b) all buses are Class "A" rated, meeting all safety regulations prescribed in the California Vehicle Code and the California Education Code; and (c) that the School District's insurance policy remains in effect; and,
- 3. That the City Manager is authorized and empowered to enter into a Letter of Agreement with the San Diego Unified School District reflecting the terms of this Resolution. This Letter of Agreement is on file in the Office of the City Clerk as Document No. RR- 287466

BE IT FURTHER RESOLVED, that the expenditure of approximately one hundred thousand dollars (\$100,000) from Police Department budgeted funds (Fund 100, Department 110, Organization 497, Job Order 111507, Object Account 4455) is hereby authorized solely and exclusively for the purpose of providing funds for the School Safety Patrol Summer Camp.
