Amendment to Agreement with Kid's Copy (Imani Kuumba College), for Project Gold Star activities and for building operation and maintenance of the Tubman Chavez Center, under the terms and conditions set forth in the Amendment to Agreement on file in the office of the City Clerk as Document No. RR- $\frac{287469}{}$

3. That the expenditure of an amount not to exceed \$166,570, is hereby authorized, solely and exclusively for the purpose of providing funds for the above mentioned amendment to agreement for Project Gold Star activities and for building operation and maintenance of the Tubman Chavez Center.
