## RESOLUTION NUMBER R-287506 ADOPTED ON JUNE 11, 1996

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to execute a Settlement Agreement with the plaintiffs in the case <u>San Dieguito Partnership</u>, L.P., et al. v. City of San Diego, et al., Superior Court Case No. 675245 (the "Litigation), on the terms and conditions set forth in the agreement on file in the Office of the City Clerk as Document No. RR-287506—, together with such ancillary terms as may be necessary to carry out the purpose and intent of the settlement.

BE IT FURTHER RESOLVED, that the City Manager be and he is authorized to execute a Stipulation for Judgment in the Litigation, in order to implement the terms of the Settlement Agreement, on the terms and conditions set forth in the Stipulation on file in the Office of the City Clerk as Document No. RR- 287506 2.

BE IT FURTHER RESOLVED, that the amount of \$200,000 shall be transferred from the Open Space Acquisition Bond Fund, 79104, to the San Dieguito Valley Trust Fund; the amount of \$270,000 shall be transferred from the Habitat Acquisition Fund, 10571, to the San Dieguito Valley Trust Fund; and the amount of \$570,000 shall be transferred from the Environmental Growth Fund, 105052, to the San Dieguito Valley Trust Fund, all to carry out the terms and conditions of the Settlement Agreement.

BE IT FURTHER RESOLVED, that the amount of \$550,000 shall be transferred from the San Dieguito Valley Trust Fund to the Public Liability Fund No. 81140, Object Acct. No. 4824, Job Order No. 081141, to repay an advance made by the Public Liability Fund towards the settlement of the Litigation.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to pay to plaintiffs the sum of \$550,000 towards the settlement of the Litigation, from the San Dieguito Valley Trust Fund.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$550,000, made payable to San Dieguito Partnership, L.P., c/o Roy Collins at R. B. Collins and Associates, 5963 La Place Court, Suite 109, Carlsbad, California 92008, towards settlement of the Litigation.

BE IT FURTHER RESOLVED, that the City Manager, and City
Auditor and Comptroller be and they are hereby authorized to take
any further actions as may be necessary or proper, including the
transfer, payment or deposit of funds to or from the San Dieguito
Valley Trust Fund to implement the Settlement Agreement and
Stipulated Judgment.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to reallocate, as may be necessary or proper, the amounts transferred for this purpose
