
ADOPTED ON JUN 24 1996

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Housing Our People Economically (HOPE), for the design and construction of a children's playground at Lincoln Park Cooperative, at the northwest corner of 49th Street and Ocean View Boulevard, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 287531.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$35,000 from CDBG Fund 18531, Dept. 4082, Org. 8219, J.O. 112599, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
