

RESOLUTION NUMBER R-287553

ADOPTED ON JUNE 25, 1996

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO LEVYING AN ANNUAL ASSESSMENT WITHIN PREVIOUSLY ESTABLISHED BUSINESS IMPROVEMENT DISTRICTS FOR JULY 1, 1996, THROUGH JUNE 30, 1997 (FY 1997).

WHEREAS, the Council of The City of San Diego (the "Council"), in accordance with the Parking and Business Improvement Association Law of 1989 (Streets and Highways Code section 36500 et seq.) wishes to continue the promotional activities within existing business improvement districts (the "districts"); and

WHEREAS, the Council, on June 3, 1996, by Resolution No. R-287452, set the date of June 25, 1996, at the hour of 10:00 a.m. in the Council Chambers of the City Administration Building, 202 C Street, San Diego, California, as the time and place when and where any and all interested persons having a desire to be heard may appear and state their views for or against the continuance of each district or the furnishing of specific types of improvements or activities within each district; and

WHEREAS, the Council, on June 3, 1996, by Resolution No. R-287451, accepted the budget report for each business improvement district within the City of San Diego, NOW,
