

RESOLUTION NUMBER R- 287656

ADOPTED ON JUL 16 1996

WHEREAS, on October 30, 1995, The City of San Diego submitted an application to the Development Services Department for a Progress Guide and General Plan Amendment, Neighborhood 10 Precise Plan Amendment, Carmel Valley Community Plan Amendment, Carmel Valley Planned District Ordinance Amendment and Local Coastal Program Amendment; and

WHEREAS, the permit was set for a public hearing to be conducted by the Council of The City of San Diego; and

WHEREAS, the issue was heard by the Council on July 16, 1996; and

WHEREAS, the Council of The City of San Diego considered the environmental impacts addressed in Environmental Impact Report No. 91-0834 in its review of the proposed Addendum DEP No. 96-0240 to Environmental Impact Report DEP No. 91-0834; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it is hereby certified that Addendum to Environmental Impact Report No. 96-0240, on file in the office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970 (California Public Resources Code section 21000 et seq.), as amended, and the State guidelines thereto (California Code of Regulations section 15000 et seq.), that the report reflects the independent judgment of The City of San Diego

as Lead Agency and that the information contained in said report, together with any comments received during the public review process, has been reviewed and considered by this Council, in connection with the amendments to the Progress Guide and General Plan, Carmel Valley Community Plan, Carmel Valley Neighborhood 10 Precise Plan, Carmel Valley Planned District Ordinance, and North City Local Coastal Program.

BE IT FURTHER RESOLVED, that the Council did as part of the Environmental Impact Report No. 91-0834 adopt Findings pursuant to California Public Resources Code section 21081 and California Code of Regulations section 15091.

BE IT FURTHER RESOLVED, that the Council did as part of the Environmental Impact Report No. 91-0834 adopt Statement of Overriding Considerations pursuant to California Code of Regulations section 15093.

BE IT FURTHER RESOLVED, that the Council did as part of the Environmental Impact Report No. 91-0834 adopt the Mitigation Monitoring and Reporting Program pursuant to California Public Resources Code section 21081.6.

BE IT FURTHER RESOLVED, that the Council as a result of the current project has determined that there are no new significant environmental impacts not considered in the previous EIR and that the Findings, Statement of Overriding Considerations, and the

Mitigation Monitoring and Reporting Program adopted with the original project (No. 91-0834) are incorporated herein by reference.
