(CCBA) Project.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the Chinese Benevolent Association, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 287798

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer and reprogram \$75,000 from the deleted Downtown Medians Project, Fund No. 18530, Dept. 4061, Org. 6103 and 1996 funding of an additional \$75,000 to the Chinese Consolidated Benevolent Association, Fund 18531, Dept. 4082, Org. 8209, and the 1997 additional funding of \$50,000 to the Chinese Consolidated Benevolent Association, Fund 18532, Dept. 4112, Org. 1207, for the rehabilitation of the existing CCBA Historical Building.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$200,000 from Fund 18532, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
