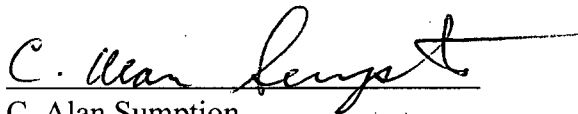
ADOPTED ON SEPTEMBER 10, 1996
