BE IT FURTHER RESOLVED, that the additional expenditure of \$172,000.00 from CIP 12-097.0, GENOA DRIVE SLOPE REPAIR, TransNet Fund 30300, to supplement funds previously authorized by Resolution No. R-286153 and R-287202 for GENOA DRIVE SLOPE REPAIR, adopted on July 24, 1995 and April 15, 1996 respectively, for the purpose of executing this First Amendment to consultant Agreement and the construction contract and related costs.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
