## RESOLUTION NUMBER R- 287875 ADOPTED ON SEP 3 0 1996

WHEREAS, in 1993 the Council of The City of San Diego created Neighborhood Service Centers ("NSC"s) in order to demystify City government and provide basic City services in the neighborhoods, thereby reducing the need for citizens to come downtown; and

WHEREAS, four (4) NSCs were created as part of the original program; and

WHEREAS, in June of 1996 the NSC concept was reinforced by the Report to the Renaissance Commission which recommended that Community Service Centers be created which would expand NSCs by opening additional centers and including an interdisciplinary Community Service Team; and

WHEREAS, in addition to providing information and services, the Community Service Centers would emphasize an integrated and coordinated approach to delivering services; NOW, THEREFORE,

BE IT RESOLVED, by the Council for The City of San Diego, as follows:

1. That it hereby approves Phase II of the Community Service Center Implementation Plan, and authorizes the City Manager to proceed with finding neighborhood areas for four (4) new Community Service Centers from the list of six (6) community clusters, and to return to the Public Safety and Neighborhood Services Committee with a proposed site selection matrix that incorporates community needs in prioritizing where the Centers should be sited for Phase III and future phases.

- 2. That the City Manager be, and is hereby authorized and empowered, to negotiate and execute leases for the four (4) new Community Service Centers, with the leases being drawn up in accordance with the City's general lease standards, subject to compliance with all applicable City regulations, and at locations approved by the office of the City Council member for the Council District in which the Community Service Center is to be located.
- That an amount not to exceed three hundred seventy five thousand dollars (\$375,000.00) is hereby authorized, solely and exclusively for the purpose of providing funds for implementation of the Community Service Centers Implementation Plan.
