A RESOLUTION DETERMINING AND DECLARING THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY OF THE CITY OF SAN DIEGO REQUIRE THE ACQUISITION OF ONE PARCEL OF PROPERTY IN THE AREA KNOWN AS GOLDFINCH CANYON FOR OPEN SPACE PURPOSES, SAID PROPERTY SPECIFICALLY BEING LOTS 5 THROUGH 12 IN BLOCK 11 OF ARNOLD & CHOATE'S ADDITION, LOCATED IN THE UPTOWN COMMUNITY, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA: AND THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY DEMAND THE ACQUISITION OF FEE SIMPLE ABSOLUTE TO SAID PROPERTY FOR THE GOLDFINCH CANYON PROJECT: THAT SAID PROPERTY IS DEEMED NECESSARY FOR COMPLETION OF THE PROJECT; AND DECLARING THE INTENTION OF THE CITY OF SAN DIEGO TO ACQUIRE SAID PROPERTY UNDER EMINENT DOMAIN PROCEEDINGS: AND DECLARING THAT AN OFFER TO PURCHASE THE PROPERTY PURSUANT TO GOVERNMENT CODE SECTION 7267.2 HAS BEEN MADE TO THE KNOWN HEIRS AND DEVISEES OF THE RECORD OWNER OF SAID PROPERTY, WHO IS DECEASED; AND DIRECTING THE CITY ATTORNEY OF THE CITY OF SAN DIEGO TO COMMENCE AN ACTION IN THE SUPERIOR COURT OF THE STATE OF CALIFORNIA, IN AND FOR THE COUNTY OF SAN DIEGO, FOR THE PURPOSE OF CONDEMNING AND ACQUIRING SAID PROPERTY.

WHEREAS, the Council of The City of San Diego has provided notice to those persons designated in Section 1245.235. Code of Civil Procedure and also has

provided all persons a reasonable opportunity to appear and be heard on the matters referred to in Section 1240.030, Code of Civil Procedure; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. That the public interest, convenience and necessity of The City of San Diego, and the inhabitants thereof, require the acquisition of one parcel of property in the area known as Goldfinch Canyon for open space purposes, said property specifically being Lots 5 through 12 in Block 11 of the Arnold & Choate's Addition, located in the Uptown Community, as more particularly described hereinafter, and that the City Council has found and determined the foregoing.

Section 2. That the public interest, convenience and necessity of said City, and the inhabitants thereof, demand the acquisition and taking of fee simple absolute to said property for the retention of open space for the Goldfinch Canyon Project; and that said real property lies within the City of San Diego, County of San Diego, State of California.

Section 3. That Section 220, Charter of The City of San Diego; Sections 1240.010, 1240.110, 1240.120, 1240.610 and 1240.680, Code of Civil Procedure; Parks and Playground Act of 1909; Sections 6950-6954, 37350.5, 38002, 38010, 39732, 40401(b), and 51063, Government Code; and Section 61.0601, et seq., San Diego Municipal Code, permit the acquisitions referenced herein.

Section 4. That the parcel of real property sought to be condemned is described as follows:



Parcel 44 - McCann

Lots 5 through 12, inclusive, in Block 11 of Arnold & Choate's Addition, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 334, filed in the Office of the County Recorder of San Diego County, November 29, 1872.

Section 5. That the taking and acquiring by said City of the real property hereinabove described is deemed necessary for the Goldfinch Canyon Project for the preservation of said land in its natural condition, for municipal purposes; that such use is a public use authorized by law (Section 220, Charter of The City of San Diego; Sections 1240.010, 1240.110, 1240.120, 1240.610 and 1240.680, Code of Civil Procedure; Parks and Playground Act of 1909; Sections 6950-6954, 37350.5, 38002, 38010, 39732, 40401(b) and 51063, Government Code; and Section 61.0601, et seq., San Diego Municipal Code); that for such public use, it is necessary that The City of San Diego condemn and acquire said real property; that said real property is to be used for the Goldfinch Canyon Project for open space purposes which is planned and located in a manner most compatible with the greatest public good and the least private injury; and that the City Council has so and found and determined all of the foregoing.

Section 6. That the offer required by Section 7267.2 of the Government Code has been made to the known heirs and devisees of the owner of record, who is deceased.

Section 7. That the City Attorney of The City of San Diego be, and he is hereby authorized and directed to commence an action in the Superior Court of the State of California, in and for the County of San Diego, in the name and on behalf of The City of San Diego, against all owners and claimants to an interest in the above-described real property, for the purpose of condemning and acquiring the fee interests as above-described for the use of said City.
