as more particularly described in said Grant Deed, a copy of which is on file in the office of the City Clerk as Document No. RR-288005-2, is hereby approved.

That the City Manager or his designee be, and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-288005-3, quitclaiming to BURNHAM PACIFIC PROPERTIES, INC., a California corporation, all of the City's right, title and interest in the sewer easement in a portion of Lot 2 of Navajo Shopping Center, Map No. 4721, as more particularly described in the quitclaim deed.
- 3. That the City Clerk shall cause the deeds, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder, the easement deeds recorded at no fee, for the benefit of the City, with no documentary tax due.
