- 1. That the City Manager is hereby authorized and empowered to request on behalf of the City, advance funding for CIP 52-631.0, the City Heights Urban Village Wightman Street Widening, from SANDAG through the debt financing program in an amount not to exceed three million five hundred thousand dollars (\$3,500,000) for property acquisition and construction of the above-named public improvements.
- 2. That, pursuant to this request, the City Manager is hereby authorized and empowered to execute all necessary documents related to the receipt of the advance funding for CIP 52.631.0 from SANDAG.
- 3. That the City Manger is hereby authorized to pay, on behalf of the City, the City's proportionate share of the issuance costs and overall annual debt service requirements of the SANDAG debt financing program and that these costs shall be the first priority use of The City of San Diego's annual allocation of TRANSNET revenues.
- 4. That the expenditure of an amount not to exceed three million five hundred thousand dollars (\$3,500,000) from TRANSNET Bond Fund 30302, Capital Improvements

Project (CIP) 52-631.0, for the City Heights Urban Village Wightman Street Widening, from 43rd Street to Highland Avenue.
