A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING A REPRESENTATIVE PROJECT AREA COMMITTEE FOR THE COLLEGE COMMUNITY REDEVELOPMENT PROJECT AREA.

WHEREAS, at its September 22, 1992, meeting, the Council of The City of San Diego (the "Council") by Resolution No. R-280718, adopted the Procedure for Formation of a Project Area Committee ("PAC") for the College Community Redevelopment Project (the "Project"); and

WHEREAS, California Health and Safety Code section 33386 provides for the Redevelopment Agency of The City of San Diego (the "Agency") to consult with the PAC for three (3) years from the date of adoption of the Redevelopment Plan, subject to one year extensions thereafter; and

WHEREAS, after proper notice, an election was conducted on October 1, 1996, in accordance with the above referenced procedures and under the supervision of a representative from the City Clerks Office; and

WHEREAS, the elected members of the PAC has submitted to the Council information establishing the qualifications of each relative to district, category or organization as appropriate;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the College Community Redevelopment Project Area Committee consisting of persons named on the list of Project Area Committee members receiving the highest number of

votes is hereby approved as constituting a representative Project Area Committee. A copy of the list of Project Area Committee members is attached hereto as Exhibit A and incorporated herein by this reference.

2. That the Council hereby concurs that the election results are valid and binding in accordance with the procedures so adopted by Resolution No. R-280718.

3. That the Project PAC be extended for a period of one (1) year from the date of this resolution.
