## RESOLUTION ADOPTING A COMPREHENSIVE CONFLICT OF INTEREST CODE FOR THE CITY'S LAND USE BOARDS AND COMMISSIONS

WHEREAS, on February 13, 1995, the San Diego City Council adopted Ordinance No.0-18162, which in part amended San Diego Municipal Code (SDMC) section 26.0106 entitled "Land Use Boards and Commissions" to require certain City land use boards and commissions to adopt conflict of interest codes with a narrowly defined scope of disclosure as delineated in SDMC section 26.0106; and

WHEREAS, on March 20, 1995, by Resolution No. R-285467, the City Council adopted new or revised conflict of interest codes for each of the below-named boards and commissions, incorporating the disclosure requirements of SDMC section 26.0106:

- Agricultural Board
- Crest Canyon Park Reserve Advisory Committee
- Grading Advisory Board
- -Historical Site Board
- La Jolla Shores Planned District Advisory Board
- La Jolla Underwater Park Advisory Committee
- Los Penasquitos Canyon Preserve Task Force
- Mission Trails Regional Park Task Force
- Old Town San Diego Planned District Design Review Board
- Relocation Appeals Board
- Tecolote Canyon Citizen Advisory Board
- Tecolote Canyon Natural Park Task Force
- Wetlands Advisory Board;

and

WHEREAS, by terms of SDMC section 26.0106, the disclosure and filing requirements are the same for every member of the above-cited land use boards and commissions; therefore, it is unnecessarily duplicative and inefficient for each of the above-cited boards and commissions to have separate conflict of interest codes;

WHEREAS, the City Council desires to eliminate duplication and consolidate the conflict of interest codes for the above-cited boards and commissions into one comprehensive code.

NOW, THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego that Resolution No. R-285467 is rescinded.

BE IT FURTHER RESOLVED by the City Council that one comprehensive conflict of interest code governing all of the above-cited land use boards and commissions is hereby adopted.


BE IT FURTHER RESOLVED by the City Council that the terms of 2 California Code of Regulations section 18730 and any amendments to that regulation duly adopted by the Fair Political Practices Commission (FPPC) are hereby adopted and incorporated by reference as the body of that comprehensive conflict of interest code.

BE IT FURTHER RESOLVED that a copy of 2 California Code of Regulations section 18730 and any amendments to that regulation be placed on file with the City Clerk as Document No. RR-287942-1.

BE IT FURTHER RESOLVED by the City Council that Appendix A, which designates positions on the above-named land use boards and commissions to be subject to the conflict of interest code, and Appendix B, which sets forth the financial disclosure requirements for those positions, as prescribed in SDMC section 26.0106, are hereby adopted.

BE IT FURTHER RESOLVED that persons required to file SEI's under this resolution and SDMC section 26.0106 shall file their SEI's with the Chair of their respective board or commission, who shall forward the originals to the City Clerk.

BE IT FURTHER RESOLVED that SEI's filed by designated persons be retained by the Office of the City Clerk and be made available for public inspection and reproduction.



BE IT FURTHER RESOLVED that the comprehensive Conflict of Interest Code adopted for the above-named land use boards and commissions shall become effective upon the date of adoption of this resolution.
