A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REALLOCATING COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS FOR USE BY THE ENTERPRISE ZONE JOB REFERRAL SERVICE FOR JOB PLACEMENT SERVICES AND AUTHORIZING THE EXPENDITURE OF \$79,000 FOR THAT PURPOSE.

WHEREAS, on April 23, 1996, the Council of The City of San Diego (the "Council") by Resolution No. R-287238, allocated Seventy-Nine Thousand Five Hundred Dollars (\$79,500) in Community Development Block Grant ("CDBG") funds, (\$69,500 for Enterprise Community Administration, and \$10,000 for Business Development and Job Placement); and

WHEREAS, it has been discovered that large portions of the state and federal job placement programs overlap; and

WHEREAS, these job placement activities can best be accomplished by utilizing an existing mechanism, the Enterprise Zone Job Referral Service; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Sixty-Nine Thousand Five Hundred Dollars (\$69,500) in CDBG monies previously allocated for Enterprise Community Administration and Ten Thousand Dollars (\$10,000) for Business Development and Job Placement, be reallocated for job placement activities by the Enterprise Zone Job Referral Service.

- 2. That the City Auditor is hereby directed to transfer Sixty-Nine Thousand Five Hundred Dollars (\$69,500) from Fund 18532, Dept. 4110, Org. 1001, and Ten Thousand Dollars (\$10,000) from Fund 18532, Dept. 4114, Org. 1403, to Fund 18532, Dept. 4114, Org. 1412.
- 3. That the expenditure of an amount not to exceed Seventy-Nine Thousand Five Hundred Dollars (\$79,500) from Fund 18532, Dept. 4114, Org. 1412, is hereby authorized solely and exclusively for the above stated purpose.
