A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROPRIATING NINE HUNDRED FIFTY THOUSAND DOLLARS IN FISCAL YEAR 1997 CITIZENS OPTIONS FOR PUBLIC SAFETY GRANT FUNDS FOR THE DESIGN AND CONSTRUCTION OF THE CENTRAL AREA POLICE SUB-STATION .

WHEREAS, on October 21, 1996, The City of San Diego received nine hundred fifty thousand dollars (\$950,000) from the State of California pursuant to the Citizens Options for Public Safety (COPS) grant to, among other things, aid in the establishment of neighborhood policing approaches; and

WHEREAS, the San Diego Police Department has discovered a need for greater neighborhood police presence in the Central area comprised of Logan Heights, Barrio Logan, Sherman Heights, Golden Hill, Grant Hill, and nearby areas; and


WHEREAS, the Council of The City of San Diego wishes to use Nine Hundred Fifty Thousand Dollars (\$950,000) of COPS grant funds for the design and construction of the Central Area Police Sub-Station to achieve this neighborhood police presence; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Nine Hundred Fifty Thousand Dollars (\$950,000) of COPS grant funds be allocated for use in the design and construction of the Central Area Police Sub-Station.

2. That the expenditure of an amount not to exceed Nine Hundred Fifty Thousand Dollars (\$950,000) is hereby authorized, solely and exclusively, for design and construction of the Central Area Police Sub-Station.
