- 1. That the filing of a joint application with the San Dieguito River Park Joint Powers Authority for the Habitat Conservation Fund Grant Program under the California Wildlife Protection Act of 1990 State grant assistance for the Bernardo Bay Natural Area Trails Plan project is hereby approved.
- 2. That this Council certifies that said applicant understands the assurances and certification in the application form.
- 3. That this Council certifies that The City of San Diego has or will have available prior to commencement of any work on the project included in this application, the required match, and will have sufficient funds to operate and maintain the project.
- 4. That this Council hereby approves the designation of the Executive Director of the San Dieguito River Park Joint Powers Authority as agent of the City to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, payment requests, together with any reasonably necessary modification or amendments thereto which may be necessary in order to carry out the purpose and intent of this project.
