AN ORDINANCE AMENDING ORDINANCE NO. 18424 (NEW SERIES), ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1997-98 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-18424, AS ADOPTED THEREIN, BY TRANSFERRING FUNDS FROM THE POLICE DEPARTMENT AND OTHER CITY GENERAL FUND DEPARTMENTS, AND TO REALLOCATE FUNDS IN THE FIRE DEPARTMENT TO FUND A TRUCK COMPANY CREW IN THE FIRE DEPARTMENT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. OO-18424 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1997-98 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" be and the same is hereby amended by amending Document No. 00-18434, as adopted therein, by transferring funds from the Police Department and other City General Fund departments, and reallocating funds in the Fire Department to fund a truck company crew in the Fire Department, pursuant to City Manager Report No. 97-153.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
