AN ORDINANCE AMENDING R1-40000, R1-20000, R1-15000, R1-10000, R1-8000, R1-6000, and R1-5000 OF THE SAN DIEGO MUNICIPAL CODE AS APPLIED IN AREAS DESIGNATED "URBANIZED" BY THE PROGRESS GUIDE AND GENERAL PLAN BY RENUMBERING THE ZONES TO THE NEW SINGLE UNIT RESIDENTIAL ZONES RS-1-1, RS-1-2, RS-1-3, RS-1-4, RS-1-5, RS-1-6, AND RS-1-7 AND AMENDING R1-40000, R1-20000, R1-15000, R1-10000, R1-8000, R1-6000, AND R1-5000 OF THE SAN DIEGO MUNICIPAL CODE AS APPLIED IN AREAS DESIGNATED "PLANNED URBANIZING" AND "FUTURE URBANIZING" BY THE PROGRESS GUIDE AND GENERAL PLAN BY RENUMBERING THE ZONES TO THE NEW SINGLE UNIT RESIDENTIAL ZONES RS-1-8, RS-1-9, RS-1-10, RS-1-11, RS-1-12, RS-1-13, AND RS-1-14 ALL RELATING TO ZONING.

BE IT ORDAINED, by the Council of The City of San Diego, that the San Diego Municipal Code and the Land Development Code are hereby amended as follows:

Section 2. That property in the portion of the City shown as "Planned Urbanizing and Future Urbanizing" on Drawing No. B-4081, on file in the office of the City Clerk as Document No. OO-_______, (a copy of which is attached hereto as Exhibit A) be and the same is hereby zoned to new single unit residential zones as follows:

R1-40000	RS-1-8
R1-20000	RS-1-9
R1-15000	RS-1-10
R1-10000	RS-1-11
R1-8000	RS-1-12
R1-6000	RS-1-13
R1-5000	RS-1-14

Section 3. City departments are instructed not to issue any permit for development that is inconsistent with this ordinance unless application for such permit was submitted and deemed complete by the City Manager prior to the date this ordinance becomes effective.

Section 4. This ordinance shall not take effect until unconditionally certified by the Coastal Commission as an amendment to the San Diego Local Coastal Program and, if so certified shall take effect on the effective date of the Land Development Code adopted by


