AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO CHANGING 12.7 ACRES LOCATED ON THE SOUTHEAST CORNER OF MERCY ROAD AND KIKA COURT, WEST OF INTERSTATE 15, WITHIN THE MIRA MESA COMMUNITY PLANNING AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE A1-10, A1-10(HR), AND R1-10(HR) ZONES INTO THE R-3000 AND R-3000(HR) ZONES, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTIONS 101.0410 AND 101.0454, AND REPEALING ORDINANCE NO. O-17198 (NEW SERIES), ADOPTED DECEMBER 12, 1988, AND ORDINANCE NO. 8782 (NEW SERIES), ADOPTED JANUARY 31, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That 12.7 acres located on the southeast corner of the intersection of Mercy Road and Kika Court, west of Interstate 15, and legally described as Parcel 2 of Parcel Map No. 14491, in the Mira Mesa Community Plan area, in the City of San Diego, California, as shown on Zone Map Drawing No. B-4067, filed in the office of the City Clerk as Document No. OO-___18454_____, are rezoned from the A1-10, R1-10, and HR zones to the R-3000 and HR zones, as described and defined by San Diego Municipal Code sections 101.0410 and 101.0454.

Section 2: That Ordinance No. O-17198 (New Series), adopted December 12, 1988, and Ordinance No. 8782 (New Series), adopted January 31, 1963, of the ordinances of The City of San Diego are repealed insofar as the same conflict herewith.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date of adoption of this ordinance.
