A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM, BY AMENDING DOCUMENT NO. 754397, AS AMENDED, BY CHANGING THE DESCRIPTION OF CAPITAL IMPROVEMENTS PROGRAM PROJECT NO. 21-123 "FLORIDA CANYON - LANDSCAPING, PHASE 2 - IMPROVE LANDSCAPING ON BOTH SIDES OF MORLEY FIELD DRIVE FROM PARK BOULEVARD TO ALABAMA STREET" TO "FLORIDA CANYON - PHASE 2 - OTHER ADDITIONAL IMPROVEMENTS IN THE FLORIDA CANYON MASTER PLANNING AREA."

WHEREAS, the fiscal year 1977 Capital Improvements Program contains project C.I.P. 21-123 described as "Florida Canyon - Landscaping, Phase 2 - Improve landscaping on both sides of Morley Field Drive from Park Boulevard to Alabama Street," the total scope of which is to develop a natural botanic preserve in the Florida Canyon area; and

WHEREAS, the improvements specifically authorized by the description in the current year's Capital Improvements Program have been completed; and

WHEREAS, changing the present description to "Florida Canyon - Landscaping, Phase 2 - Other Additional Improvements in the Florida Canyon Master Planning Area" will permit the continuation of the same project in accordance with the Florida Canyon Master Plan; and

WHEREAS, the next phase of proposed work will be the establishment of natural plantings on the face of the recently completed Arizona Sanitary Landfill which is the most highly visible disturbed area in the canyon; and

WHEREAS, no change in amount or source of funding is requested; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to Section 2, subsection 23 of the annual appropriation ordinance, the Capital Improvements Program as contained in Document No. 754397, as amended, be and the same is hereby further amended by changing the description of Capital Improvements Program Project No. 21-123 "Florida Canyon -Landscaping, Phase 2 - Improve landscaping on both sides of Morley Field Drive from Park Boulevard to Alabama Street" to read "Florida Canyon - Phase 2 - Other additional improvements in the Florida Canyon Master Planning area."
