
BE IT RESOLVED, by the Council of The City of San Diego, that Change Order No. 1, dated October 10, 1996, heretofore filed with the City Clerk of said City as Document No.

RR- 288255, issued in connection with the contract between The City of San Diego and Vadnais Corporation for the Miramar Road Subsystem/Reclaimed Water Distribution Package "A", said contract having been filed in the office of the City Clerk as Document No. RR-286604, is hereby approved, together with the changes therein set forth, amounting to a net increase in the contract price of \$489,780.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$502,800 from Water Fund 41500, CIP 70-912.0, Miramar Road Subsystem, is hereby authorized, solely and exclusively to fund this change order, contingencies, and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure under established contract funding phases are, or will be, on deposit in the City treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.


