BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute a contract with Vadmais Corporation to perform emergency main break repair work on the Montgomery Pipeline at the northwest corner of Murphy Canyon Road and Aero Drive.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$115,000.00 from Water Fund 41500, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
