

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF WEST MIRAMAR LANDFILL PHASE II - MODULE B.

BE IT FURTHER RESOLVED, that the expenditure, \$6,100,000 from CIP No. 37-056.0, West Miramar Refuse Disposal Facility - Phase II, sublet No. 37-056.4, West Miramar Landfill Liner Module B, Environmental Services Enterprise Fund, Fund No. 41201, is hereby authorized solely and exclusively for providing funds for

said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
