
RESOLUTION NUMBER R- 288348

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, an amendment to the agreement of June 12, 1995, with Berryman & Henigar (formerly known as BSI Consultants), for an enhanced control system at the South Bay Reclamation Sewer and Pump Station, in an amount not to exceed \$390,000 and under the terms and conditions set forth in Amendment No. 1, on file in the office of the City Clerk as Document No. RR- 288348, together with any further amendments or modifications to this agreement which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$390,000 from Fund No. 41509, CIP 40-911.3, South Bay Reclamation Sewer and Pump Station, is hereby authorized, solely and exclusively to provide funds for the above amendment.


