No. 29-418.0, South Clairemont Recreation Center Parking Lot, Clairemont Mesa Development Impact Fees, Fund No. 79521; \$130,000 from unexpended Clairemont Mesa Development Impact Fees, Fund No. 79521; and \$88,650 from East Clairemont Athletic Area Public Resources Account, Fund No. 38052 to C.I.P. No. 29-440.0, East Clairemont Athletic Area - Phase II.

BE IT FURTHER RESOLVED, the City Council understands the assurances and certification in the application form.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that the City Manager or his duly designated representative, as agent of The City of San Diego, be and he is hereby authorized to:

1. conduct all negotiations, execute and submit all documents (including, but not limited to, applications, agreements, amendments, payments request, etc.) which may be

necessary for the completion of the East Clairemont Athletic Area project; and

2. accept and expend the grant funds.

BE IT FURTHER RESOLVED, that the City Council hereby authorizes the City Auditor and Comptroller to establish a special interest-bearing fund for the grant.

BE IT FURTHER RESOLVED, that the City Council certifies that it has or will have sufficient funds to operate and maintain the East Clairemont Athletic Area - Phase II.
