

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and he is hereby authorized and empowered to pay the total sum of \$150,000.00 in the settlement of each and every claim against The City of San Diego, its agents and employees, Superior Court Case No. 697817, Taboada v. City of San Diego, et al., resulting from an incident that occurred on August 29, 1995, to Manuel Taboada.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$150,000.00, made payable to Manuel U. Taboada and his attorney of record, Doc Anthony Anderson, in full settlement of the lawsuit and of all claims.

BE IT FURTHER RESOLVED, that said funds are to be payable from Fund No. 81144, Public Liability Reserve Fund.
