RESOLUTION NUMBER R-288451

ADOPTED ON MARCH 18, 1997

A RESOLUTION DETERMINING AND DECLARING THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY OF THE CITY OF SAN DIEGO REQUIRE THE ACQUISITION OF PROPERTY INTERESTS FOR THE CORAL GATE PROJECT: THE REQUIRED PROPERTY INTERESTS ARE LOCATED IN THE COMMUNITY OF SAN YSIDRO, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA; THAT THE PROJECT IS PLANNED OR LOCATED IN THE MANNER THAT WILL BE MOST COMPATIBLE WITH THE GREATEST PUBLIC GOOD AND THE LEAST PRIVATE INJURY: THAT THE PROPERTY INTERESTS SOUGHT TO BE ACQUIRED ARE DEEMED NECESSARY FOR THE CORAL GATE PROJECT: AND DECLARING THE INTENTION OF THE CITY OF SAN DIEGO TO ACQUIRE THE PROPERTY INTERESTS UNDER EMINENT DOMAIN PROCEEDINGS: AND DECLARING THAT AN OFFER TO PURCHASE THE PROPERTY PURSUANT TO GOVERNMENT CODE SECTION 7267.2 HAS BEEN MADE TO THE RECORD OWNER OF THE PROPERTY AND THE OFFER WAS REJECTED; AND DIRECTING THE CITY ATTORNEY OF THE CITY OF SAN DIEGO TO COMMENCE AN EMINENT DOMAIN ACTION IN THE SUPERIOR COURT OF THE STATE OF CALIFORNIA, COUNTY OF SAN DIEGO TO ACQUIRE THE PROPERTY INTERESTS AND IMMEDIATE POSSESSION THEREOF.

WHEREAS, the Council of The City of San Diego (CITY) has provided notice to those persons designated in Section 1245.235. Code of Civil Procedure, and also has


provided all persons a reasonable opportunity to appear and be heard on the matters referred to in Section 1240.030, Code of Civil Procedure; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that it has found and determined the following:

Section 1. That the public interest, convenience and necessity of the CITY, and the inhabitants thereof, require the acquisition of six (6) property interests for the Coral Gate Project. Said property interests include two (2) drainage easements to provide for the extension of the public storm drain system, and all incidents and appurtenances thereto, to allow the collected runoff from city streets and outlets to be diverted to an adjacent natural watercourse; one (1) slope easement which is required to support the Camino De La Plaza extension to Dairy Mart Road, providing a secondary access to the area of San Ysidro and thereby allowing public safety vehicles an alternate route; and three (3) temporary construction easements to allow adequate area in which to construct the project. All interests sought for this project are located in the San Ysidro community area, in the City of San Diego, County of San Diego, State of California, as more particularly described hereinafter.


Section 2. That the acquisitions sought herein are for a public use authorized by the following Code sections: Section 220, Charter of the City of San Diego; Sections 1240.010, 1240.110, 1240.120 and 1255.410 Code of Civil Procedure; and Sections 37350.5, 38900, 39040 and 40404 of the Government Code.

Section 3. That the project is planned or located in the manner that will be the most compatible with the greatest public good and the least private injury.



Section 4. That the acquisition and taking of the property interests described hereinafter are necessary for the Coral Gate Project for municipal purposes.

Section 5. That the parcels of real property and the interests sought to be condemned are described as follows:
