

RESOLUTION NUMBER R- 288463

ADOPTED ON MAR 31 1997

WHEREAS, the San Diego Symphony Orchestra Community Music Center (Music Center) provides a community-based music education program for sixty (60) fourth through sixth grade students from low income families residing in the Sherman Heights and Logan Heights area; and

WHEREAS, through this program students have access to an after school music education program and musical instruments; and

WHEREAS, through this program community members also have access to an English-as-a-second language class, computer literacy classes, art appreciation classes, and guitar lessons; and

WHEREAS, through this program quarterly musical recitals are performed by the children, professional guest artists give performances, and a professional who serves as a role model in the community gives presentations; and

WHEREAS, the program is part of The City of San Diego's Commission for Arts and Culture Neighborhood Arts Program; NOW, THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego, that the grant funds from the California Arts Council Multi-Residency Program be accepted.

BE IT FURTHER RESOLVED that these grant funds are accepted by The City acting as a pass-through agency to support the Music Center's community-based music education program.

BE IT FURTHER RESOLVED that the matching funds required by the grant be designated from The City's Neighborhood Arts Program budget (Fund 10220).

BE IT FURTHER RESOLVED that the City Manager or his representative is authorized to administer the grant and matching funds for the above-described purposes.
