BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer and expend an amount not to exceed \$124,827 of Federal Congestion Mitigation and Air Quality (CMAQ) funds (Fund No. 38663), and an amount not to exceed \$16,173 of State Transportation System Management (TSM) funds (Fund No. 38548) to CIP 63-038.0, contingent upon the receipt of a signed Program Supplement for Congestion Mitigation and Air Quality Funds, and Transportation System Management Funds.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon advice from the administering department, is hereby authorized to transfer funds to the appropriate reserves provided that the City Auditor first furnishes a certificate demonstrating that the funds necessary for such expenditures are, or will be, on deposit in the City Treasury.
