Wylie Construction Company, said contract on file in the office of the City Clerk as Document RR-286640, is hereby approved, together with the changes therein set forth, amounting to a net increase in the contract price of \$298,224.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$298,224 from Sewer Fund No. 41506, CIP 46-120.0, Penasquitos Trunk Sewer Relief, is hereby authorized, solely and exclusively to provide additional funds for this change order, construction, contingencies, and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure under established contract funding phases are, or will be, on deposit in the City treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to appropriate reserves on advice of the administering department.
