BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$642,350 from Fund No. 41508, CIP 46-501.0, Annual Allocation - Metro Pooled Contingency,

is hereby authorized, solely and exclusively to provide additional funds for CIP 46-104.0, North Metro Interceptor, Phase II project contingency, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City treasury.
