BE IT RESOLVED, by the Council of The City of San Diego, that Change Order No. 5 dated March 14, 1997, on file in the office of the City Clerk as Document No. RR-28862,0 issued in connection with the contract between The City of San Diego and Vadnais Corporation for North City Cogeneration Facility - Miramar Road Subsystem Extension Part 1, Package "A", said contract having been filed in the office of the City Clerk as Document No. RR-286604, is hereby approved, together with the changes therein set forth, amounting to a net increase in the contract price of \$234,838.

BE IT FURTHER RESOLVED that the expenditure of an amount not to exceed \$234,838 from Sewer Fund No. 41509, CIP 46-504.0, North City Cogeneration Facility, is hereby authorized, solely and exclusively to provide funds for this change order, contingencies, and related costs, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure under established contract funding phases are, or will be, on deposit in the City treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
