A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTION RESULTS OF MARCH 19, 1997, FOR THE BARRIO LOGAN REDEVELOPMENT PROJECT AREA COMMITTEE.

WHEREAS, the Council of The City of San Diego (the "Council") by Resolution No. R-274652, adopted the Procedure for Formation of the Project Area Committee ("PAC") for the Barrio Logan Redevelopment Project at its October 30, 1989, meeting; and

WHEREAS, on May 25, 1996, the Council by Resolution No. R-287415, approved the PAC representatives initially elected to the PAC on March 20, 1996; and

WHEREAS, since the initial March 20, 1996, election of PAC members, vacancies have occurred on the PAC; and

WHEREAS, an election of the PAC was conducted on March 19, 1997, after notice and according to the PAC bylaws and established procedures enumerate within the documents approved by the Council and a representative from the City Clerk's office attended the March 19, 1997, election to ensure its validity; and



2. That the Council hereby concurs that the election results of March 19, 1997, are valid and binding in accordance with the procedures so adopted by Resolution No. R-274652.
