APPROVING MAP OF SOUTH CREEK PARCELS 35-48 UNIT NOS. 11 AND 12.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "South Creek Parcels 35-48 Unit Nos. 11 and 12," being a subdivision of portions of the Southwest Quarter of Section 22 in Township 14 South, Range 2 West, San Bernardino Meridian, in The City of San Diego, County of San Diego, State of California, according to the official plat thereof, a portion of Parcel 2 of Parcel Map No. 17445, filed in the office of the County Recorder of San Diego County, November 10, 1994, and Lot 99 of South Creek Parcels 35-48, Unit Nos. 14 and 15, in The City of San Diego, County of San Diego, State of California, according to map thereof No. 12257, filed in the office of the County Recorder of San Diego County November 8, 1988, together with Springbrook Drive as dedicated to public use, is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted as shown on said map and subject to the conditions as set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of the public, the following: Aspen View Drive, Aspen View Court, Heatherwood Hollow Court, and Mil Pitrero Road, and said streets are hereby declared to be public streets and together with all appurtenances thereto are dedicated to the public use, as dedicated and shown on said map and

subject to the conditions as set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby finds that a portion of Springbrook Drive dedicated per Map No. 12257 is not shown, as it has been vacated pursuant to the provisions of Section 66499.20 ½ of the State Subdivision Map Act.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Springbrook Drive, adjacent and contiguous to Lots 53, 66 and 87, all as shown on this map within this subdivision. The City Engineer is authorized to revest all or part of said access rights if there is a change in circumstances making access necessary and safe.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the building restricted easement over, upon, or across all of Lots 89 through 92, inclusive, and a portion of Lot 93, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the open space easement over, upon, or across all of Lot 88, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said

subdivision map and those actions stated above, all as shown on this map within this subdivision, which are made on behalf of The City of San Diego, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of The City of San Diego is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
