

RESOLUTION NUMBER R- 288693

ADOPTED ON MAY 27 1997

THE TEXT AND FORMAT OF THIS RESOLUTION ARE AS REQUIRED BY THE DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL FOR GRANT ACCEPTANCE

WHEREAS, the City of San Diego Police Department desires to apply for, accept and expend a grant for a project known as the Vice/Alcoholic Beverage Control project, to be funded in part from funds made available through the Grant Assistance to Local Law Enforcement Agencies Project administered by the Department of Alcoholic Beverage Control (hereafter referred to as ABC); and

WHEREAS, the goals of the project are to reduce access to alcohol by minors city-wide, with special emphasis on the highly-impacted target areas of Mission Beach and Gaslamp; and to reduce alcohol-related youth offenses; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief of Police of the City of San Diego, by and through the City Manager, is hereby authorized and empowered, for and on behalf of the City of San Diego, to submit and, if selected to accept funding for the proposed program, a copy of which is on file in the Office of the City Clerk as Document No. RR- 288693, to ABC;

BE IT FURTHER RESOLVED, that the Chief of Police of the City of San Diego is hereby authorized and empowered to execute, on behalf of the City of San Diego, the resultant program and contract, including any extensions or amendments thereof, and any subsequent contract with the State in relation thereto;

BE it further resolved, that Council hereby authorizes the Chief of Police of the City of San Diego to execute all aspects of grant program operation, and to certify that the City will comply with all applicable statutory or regulatory requirements related to said program;

BE IT FURTHER RESOLVED, that any liability arising out of the performance of this contract, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and ABC disclaim responsibility for any such liability;

BE IT FURTHER RESOLVED, that the Chief of Police of the City of San Diego is authorized to provide the matching resources as committed to this grant program;

BE IT FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant expenditures controlled by this body;

BE IT FURTHER RESOLVED, that any staff positions funded under this grant award shall not be subject to local hiring freezes.




