BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized to execute a Third Amendment to the Operating Agreement with Wackenhut Corrections Corporation, a copy of which is on file in the office of the City Clerk as Document No. RR- 288706, which will allow the City to: (1) terminate the Operating Agreement upon ninety (90) day written notice; and (2) enter into agreements with other law enforcement agencies to house their misdemeanor prisoners.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby authorized to exercise the option to renew the Operating Agreement with the Wackenhut Corrections Corporation, for the Misdemeanor Pre-Arrest Detention Facility for a period of five (5) years, commencing May 10, 1997, as provided in the second amendment to the Operating Agreement dated June 24, 1991, on file in the office of the City Clerk as Document No. RR-278192-1.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and is hereby authorized to expend \$642,226 from Fund 103551 for Fiscal Year 1997, and subsequent annual

expenditures dependent upon annual appropriations for this purpose.
