BE IT RESOLVED, by the Council of The City of San Diego, that Change Order No. 8, dated February 28, 1997 and on file in the office of the City Clerk as Document Number RR- 288829, issued in connection with the contract between The City of San Diego and APC/T&K Mechanical, for the Metro Biosolids Center - Digester Complex, said contract having been filed in the office of the City Clerk as Document Number RR-285825, be and the same is hereby approved, together with the changes therein set forth, amounting to a net increase in the contract price of \$236,323.


BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$236,323 from Fund No. 41509, CIP 42-911.4, Metro Biosolids Center, is hereby authorized, solely and exclusively to provide additional construction for this change order, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$5,000,000 from Fund No. 41509, CIP 42-911.4, Metro Biosolids Center, is hereby authorized, solely and exclusively to provide funds for additional contingencies and related costs in connection with this project, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure under established contract funding phases are, or will be, on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
