WHEREAS, the City of San Diego is a signatory to the 1991 Memorandum of Understanding Regarding Urban Water Conservation in California, which contains "Best Management Practices" that are statewide standards for achieving long-term water conservation, including incentives to facilitate implementation of water conservation programs;

WHEREAS, on October 9, 1993, the City Council adopted Council Policy 900-12, which establishes a policy of providing incentives, including fee credits and reimbursement for cost of improvements which provide future revenue, to promote business attraction and retention in state-designated "Enterprise Zones" with high levels of unemployment;

WHEREAS, the Enterprise Zone Water Conservation Business Incentive Program will provide financial benefits to City water customers who make extraordinary efforts to conserve water by utilizing seawater instead of potable water, and are located in designated Enterprise Zones; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized to establish an Enterprise Zone Water Conservation Incentive Program.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized to enter into and execute agreements with participants of the Enterprise Zone Water Conservation Business Incentive Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to transfer \$700,000 within the Water Operating Fund 41500 from the Unallocated Reserve (Program Element 76226, Object Account 4903) to the Commercial/Industrial Water Conservation Program (Program Element 76254, Object Account 4222).

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized an expenditure not to exceed \$700,000 from the Water Department Operating Fund (41500), for the sole and exclusive purpose of implementing the Enterprise Zone Water

Conservation Business Incentive Program.
