
ADOPTED ON JUN 30 1997

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Joint Powers Agreement with the California Department of Corrections ("CDC"), to fund improvements to the Otay Mesa Road Widening Project, CIP No. 52-619.0, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 288872

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$472,872 from the California Department of Corrections to Fund No. 38951, CIP 52-619.0.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$472,872 from CIP No. 52-619.0, "Otay Mesa Road Widening Project," Fund No. 38951, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project, contingent upon the receipt of the signed program supplement.
