- 2. an amount not to exceed \$542,000 from Fund No. 41500, CIP 70-912.0, Miramar Road Subsystem, solely and exclusively to provide additional funds for contingency and related

costs, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City Treasury; and

3. an amount not to exceed \$300,000 from Fund No. 41500, CIP 70-942.0, Annual Allocation - Reclaimed Water Pooled Contingency, solely and exclusively to provide additional contingency for CIP 70-918.0, Scripps Ranch Blvd/I-15 Subsystem, provided that the City Auditor and Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
