WHEREAS, the City of San Diego's Fiscal Year 1997 Capital Improvement Program (CIP No. 392090) allocated \$865,000 toward the improvement of El Cajon Boulevard between I-805 and 54th Street; and

WHEREAS, the City received a \$565,000 ISTEA Grant toward the El Cajon Boulevard improvements; and,

WHEREAS, the match required by the ISTEA Grant would reduce the amount necessary to complete the project to \$412,000; and

WHEREAS, \$453,000 in CIP funding could be made available for other projects, NOW THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego, that it hereby authorizes an increase in El Cajon Blvd. CIP No. 392090 by \$112,000, by authorizing the transfer of \$565,000 in ISTEA Program Funds to CIP No. 392090 and authorizing the transfer of \$453,000 from CIP No. 392090 to the Renaissance Commission Transnet Fund (30300).
